### **Blowsion Dealer-Distributor Policy**

Thank you for inquiring about our terms and conditions for the Dealer and Distributor programs offered by Blowsion Kustom Design. The requirements for our Dealer and Distributor programs are listed below. Please take time to read them and, if necessary, feel free to contact one of our representatives to answer any questions you might have.

### **WHO CAN BUY FROM BLOWSION ?**

Due to the principle behind Blowsion we must limit discount purchasing to qualified "Warehouse Distributors" and "Stocking Dealers". The requirements for our Distributor and Stocking Jobber/Dealer programs are listed below and also attached.

### **DEALER/JOBBER**

\$500.00 order minimum initial order is required. Stocking Dealers must sell BLOWSION product out of a retail storefront.

All opening orders will be prepay ONLY unless credit terms have been arrange and approved.

### **TERMS & CONDITIONS**

#### **BACKORDERS**

Back ordered products will be billed and shipped as soon as they become available. Any changes or alterations in your backorder must be submitted to us via email or fax.

#### **SHIPPING**

All orders are shipped on a same day basis time permitting. Orders are shipped UPS Ground, 3 day ground track, 2 Day Air or Next Day Air, whichever you choose. Special shipping arrangements must be made when the order is placed. Any shortages or discrepancies must be reported to us within 7 working days.

### **PRICES**

All listed prices are F.O.B. Sherwood, Oregon  
All prices subject to change without notice.

### **PAYMENT**

U.S. Dollars in the form of cashiers check, wire transfer or VISA/MasterCard/AMEX. Orders cannot be shipped C.O.D./Certified Funds. BLOWSION does not accept personal checks or PAYPAL for dealer or distributor orders.

### **INTERNATIONAL ORDERS**

All international orders must be pre-paid in U.S. dollars in the form of wire transfer or valid credit card and will be shipped freight pre-paid unless other arrangements have been made and approved. It is very important that all qty orders be sent by fax or Email and contains exact shipping address and entire fax and phone number as well as e-mail address. (Include city code and country code also). When we receive an order we will always send an order confirmation by fax or Email with pricing and availability for your approval and payment. We are not responsible for import duties and/or local taxes.

### **WARRANTIES**

All Blowsion manufactured products are warranted to the original purchaser for 90 days for material and workmanship. A copy of the original invoice and a returned authorization number must accompany all items returned for warranty. Blowsion will replace or repair the product and re-ship UPS ground or US Postal mail at no charge. If shipping via UPS ground or US mail is not available, shipping charges are the responsibility of the original purchaser. All items returned for reasons other than warranty or a manufacturer's mistake will be subject to a 20% restocking fee.

### **TECHNICAL ASSISTANCE**

Experienced techs are available to provide any information you may need between the hours of 10:00 a.m. to 6:00 p.m. Pacific Standard Time. E-mail is the fastest way to get a detailed response with pictures.

**MINIMUM ADVERTISED PRICING**

Failure to adhere to these terms & policies will cause Blowsion to not accept orders from that customer for a period of one year from the date of infraction. Rules are as follows:

- **No Blowsion products can be advertised to the general public in print or Internet for less than Retail. None, no exceptions.**
- No advertising shall state “Prices too low to print” or “Prices so low Blowsion won’t let us print them” or “Blowsion price \$XXX.XX, Dealer price \$XXX.XX, call for your price” or any other low price come-ons.
- No “Group Buys” will be accepted. All distributor or dealer applications must be verified to be a valid wholesaler with a business license, resale tax number, and a list of top customers.
- Ebay auctions shall not list any “Buy it now” postings at less than Retail. All Ebay transactions must be pure auctions. No prices, whatsoever, may be shown that are below Retail.
- Distributors are responsible for your customers pricing. If they violate the Blowsion policy the distributor will suffer the consequences.
